

# Hair Extension Service Agreement

**6. CHOICE OF PRODUCTS:** The Client agrees that the Stylist has the sole discretion to determine which products, including but not limited to hair extensions, bonding materials, and maintenance supplies, will be used. These products have been selected based on quality and suitability for the Client's hair.

**7. REFUND POLICY:** All services rendered by the Stylist are provided on a non-refundable basis. In the event of any dissatisfaction with the service, the Client agrees to notify the Stylist within 48 hours to discuss potential adjustments. However, no refunds will be provided.
